I, _____, the parent (legal guardian) of _____ - _____, represent that I have full authority to enter into this consent and waiver on behalf of this named minor.

_____ (initial) Optional: Paintball Consent and Waiver. Must be 13 or older to participate.

The undersigned has asked Palomar Christian Conference Center (hereto forward referred to as PCCC) to allow the above named minor to participate in the paintball game and acknowledges that the game involves physical exertion and other risks, and may result in injury to said minor or others playing the game or observing the game; Is aware of the risk of injury, including, but not limited to being shot by a paintball, falling, tripping, snake bite, heat stroke, insect bite and stings, exposure to poisonous plants, improper use or operation of equipment by the undersigned or any other player and others not following the safety rules; Recognizes that the possibility of permanent disability (including blindness or loss of hearing) or death does exist. Recognizes said minor will need to play the game according to the rules which have been given and to follow directions given by any Game Coordinator or Referee; Warrants and acknowledges that minor's physical and mental condition will enable him/her to participate safely in the game; Understands that it is said minor's responsibility to wear safety headgear provided by PCCC (face and neck guards), long pants and long sleeve jacket and any other safety wear deemed necessary by the participant or their legal guardian. IN CONSIDERATION of being permitted to play the game, the undersigned, on behalf of said minor, hereby releases PCCC and its employees from any and all actions for damages or injury however arising, including negligence of PCCC, of the playing of the paintball game. The undersigned desires and agrees to assume any and all risks.

_____ (initial) Optional: Horseback Riding Consent and Waiver. Must be 10 or older to participate.

The undersigned has asked PCCC to allow the above named minor to participate in horseback riding and acknowledges that the activity involves physical exertion and other risks, and may result in injury to said minor; Is aware of the possibility of the risk of injury, including, but not limited to permanent disability or death. I also agree to indemnify, defend, and hold PCCC faultless and exempt from and against any and all claims, liabilities, expenses, damages, losses, causes of action, and suits (including, without limitation, attorneys' fees and costs) arising out of or in any way related to the child's participation in horseback riding at PCCC, whether caused by PCCC's active or passive negligence or otherwise.

_____ (initial) Optional: Firearm Consent and Waiver. Must be 12 or older to participate.

I do give permission to PCCC to furnish a firearm to said minor for the purpose of instructing him/her in the safe handling of firearms and safe shooting, and allowing him/her to utilize said firearm at the PCCC's rifle range. PCCC will not furnish a .22 caliber rifle to anyone under the age of 12. I understand that an adult counselor must accompany the minor. I do further agree to indemnify and consider faultless PCCC, and the officers and employees thereof, from all suits or actions brought for, or on account of, any injuries or damages received or sustained by any person or persons by or from the consequences or any negligence or any act of omission of the above named minor occurring during the course of said instruction. I understand the management reserves the right to refuse the use of the rifle range by any group or individual.

_____ (initial) Optional: Zip Line Consent and Waiver. Must be 7 or older to participate.

The undersigned has asked PCCC to allow the above named minor to participate in riding PCCC's Zip Line and acknowledges that the activity involves hights and other risks, and may result in injury to said minor; is aware of the possibility of the risk of injury, including, but not limited to permanent disability or death. I also agree to indemnify, defend, and hold PCCC faultless and exempt from and against any and all claims, liabilities, expenses, damages, losses, causes of action, and suits (including, without limitation, attorneys' fees and costs) arising out of or in any way related to the child's participation in zip line riding at PCCC, whether caused by PCCC's active or passive negligence or otherwise.

In addition to being permitted to participate in the above initialed activities, the undersigned, on behalf of the named minor, hereby waives and releases any and all claims, demands, actions, causes of action and rights (contingent, accrued, inchoate, or otherwise), and agrees to defend and hold PCCC faultless and exempt from and against any and all claims, liabilities, expenses, damages, losses, causes of action, and suits (including, without limitation, attorneys' fees and costs) arising out of or in any way related to the child's participation in activities at PCCC, regardless of any active or passive negligence on the part of PCCC. I also give permission to PCCC to use any photographs or videos of the above named minor for promotional materials, including the PCCC web site postings, without expectation of compensation.
